Blue Cross MedicareRx Basic (PDP) is a Medicare Advantage PDP plan with a Medicare contract. Enrollment in the Plan depends on contract renewal.

To join **Blue Cross MedicareRx Basic (PDP)**, you must be entitled to Medicare Part A, be enrolled in Medicare Part B, and live in our service area. Our service area covers the state of Texas.

Except in emergency situations, if you use the providers that are not in our network, we may not pay for these services unless otherwise noted in your Evidence of Coverage (EOC).
